Did you know?

Scotland is one of the most nature-depleted countries in the world. One in nine species face national extinction, and many others continue to decline.

Trees are a vital part of the solution. They stabilise soil, clean our air and water, mitigate the effects of climate change, and sustain biodiversity.

Yet Scotland's trees are in trouble:



Just 18% of Scotland has tree cover compared to a European average of 37%.



Only 4% of land is native woodland, over half of which is degraded.



Our urban tree cover is among **the lowest in Europe.**

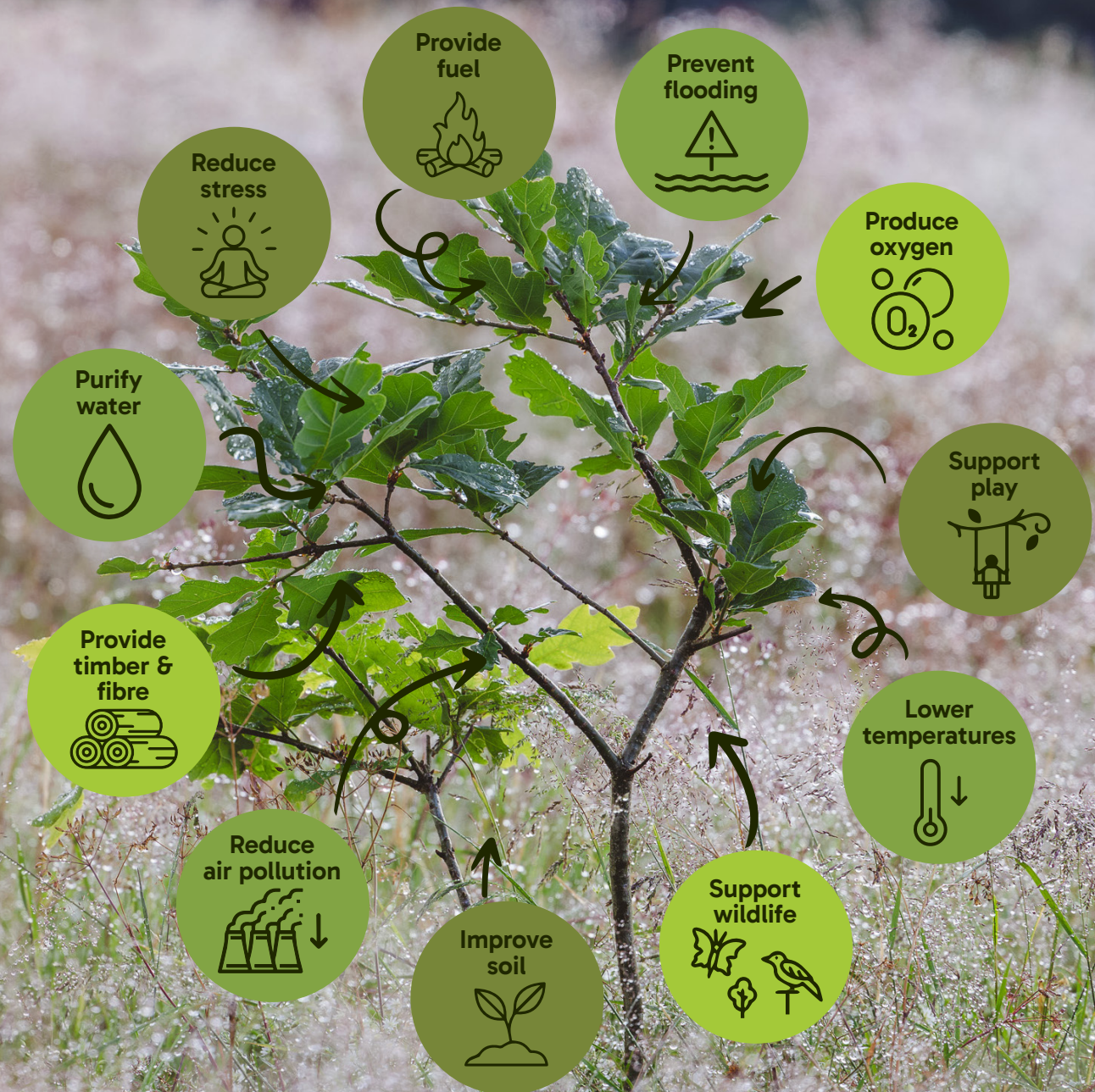


Our remaining woodlands are **under threat** from high deer numbers, climate change and disease.

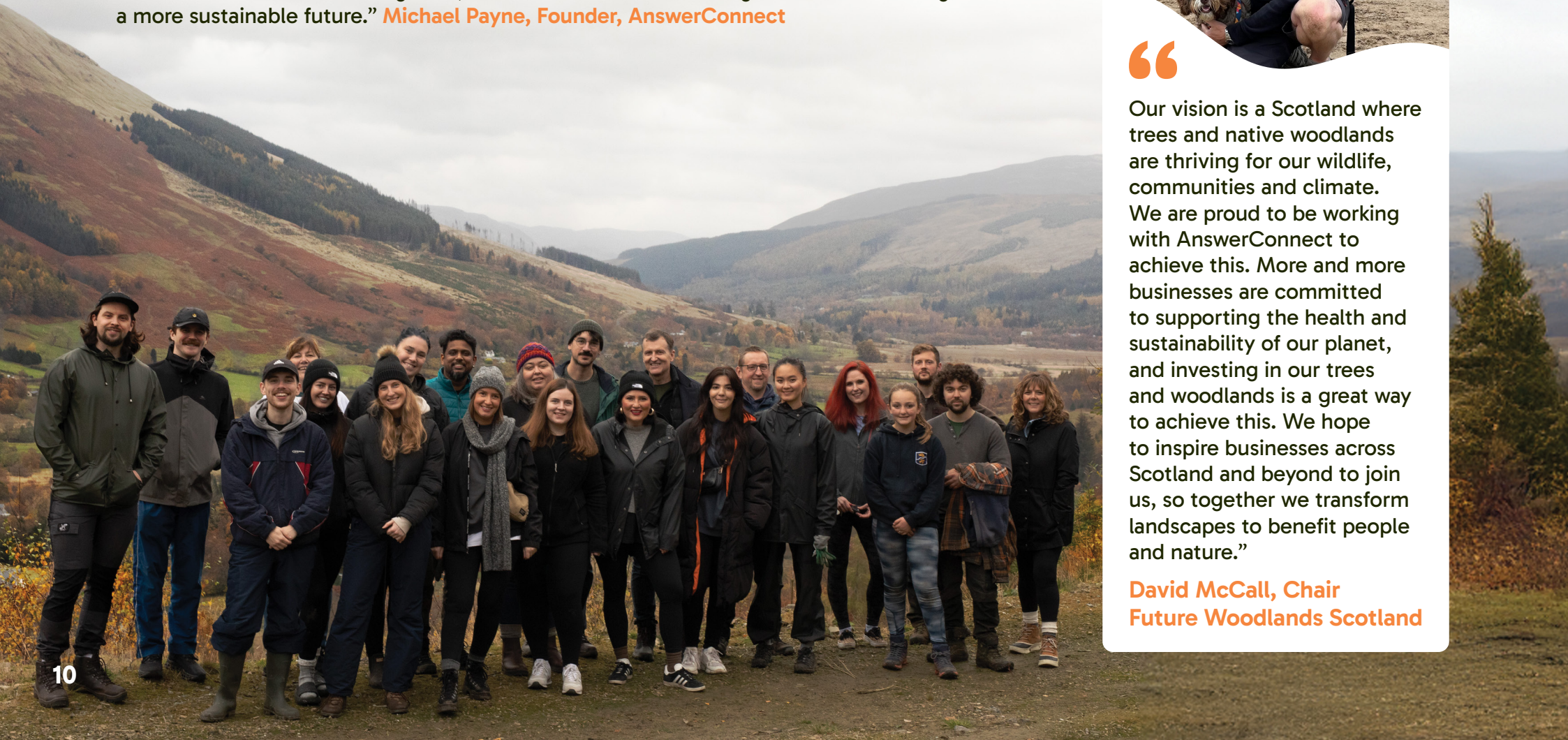
